

Minutes Bureau meeting Luxembourg 08/03/2020

Present: Svenja Hahn (SH), Antoaneta Asenova (AA), Edgaras Mascinskas (EM), Lena Höglund (LH), Dan-Aria Sucuri (DAS), Pau Castellvi Canet (PCC) and in addition Bàlint Gyévai, Secretary General (BG).

Not attending: Deimanté Rimkuté (DR).

Meeting starts at 9 h 10

Finances (BG, LH)

External auditors and update finances:

- Proposal for assistance from the External Auditors with 4 meetings a year. It would help to smoothen processes, avoid unexpected bookkeeping questions, guidance and better oversight, more professional approach but also follow up on the manual journals, cash administration, the paypal system.
- LH worked hard on making sure to comply with the advises that we got from the auditors in the past couple of days. Corrections had to be made in the manual journals of this year and last year as well. Correct balance sheets and annual results are now available.
- Result for this year is the following: 18 000 EUR surplus by the end of the year. <u>Explanation of the profit</u>: sorting out books and correcting mistakes from previous years, staff costs (change of staff), Congress costs (Brussels + London).
- Negative year next year is advisable: Staff cost and Congress costs are difficult to predict, that has to be kept in mind for the next Bureau. Cheaper fee for Congress shouldn't be done, we need our own revenues in any case. The exceeding money could be used for the 45th anniversary next year.

The annual financial report has to be signed by all Bureau members and then sent to the external auditors in order to close the books and make them approved by the Congress.



Additional financial aspects:

- Reward system was discussed and decided by the Bureau for current and future staff members.
- Mediwet: an external organisation for health support of workers following our work regulation should be subscribed for LYMEC.

Alumni network:

- Statutes refounding and meeting to relaunch the process on 17 March in the evening.
- We will have to discuss and adopt the statutes but also decide on who
 is doing what.

Next Council of Europe application for 2021:

 The topic has to be selected. LH, AA and DAS to discuss it but we would do something on equality and diversity.

Spring Congress (BG, AA)

Elections tool and validation election document

- Candidates must be announced before the relevant agenda point.
- V-P + Treasurer have 4 minutes to present their applications.
- Internal Audit and IFLRY have 2 minutes.
- Common Q/A for Bureau members, all at once.

Add a disclaimer: Wrap-up of all the existing documents to facilitate understanding of the elections process.

Newbies session:

 DAS will do it. He will be briefed by BG who prepared already a briefing.

Resolutions:

- Policy reform working group outcomes should be discussed before the rest so it will be outside of the snap vote on order of resolutions.
- 32 proposals were submitted including the 9 from the policy book reform group (document summarizing the outcomes of the working group was sent to the Bureau and shared with IOs). They propose the merger of Belarus resolutions for example and archiving of about 25 resolutions.
- FEL resolution arriving hours after the deadline can't be considered. IMS were delayed because of the change in delegates but they reached out to notify about their resolution being submitted with a small delay.



Working groups:

- 1. WG and the proposals related to civil rights, freedom, faith and gender rights.
- 2. Rest of the topics together.

We have to split tha chairs the following way, BG to come up with a comprehensive proposal:

- WG 1: Ani/Danica
- WG 2: Sissel/Monika
- Chair:
- Danica can't chair any session on finances and bureau reports since she was involved as Secretary General.
- Resolution tool:
- PCC to take care of this during the event and already before when amendments are coming in.
- BG to reach out to the service providers of the tool to take out the "page feature" to facilitate management of the tool during Congress and avoid the situation we had last time.
- Coronavirus related actions and communication:
- Give recommendation/disclaimer: "Congress is going to take place: precautions and measurements - wash your hands, not have close physical contacts, hand-shaking and encounters, use sanitisers. In addition, we are monitoring the situation on the ground."
- In practice, this means that we have to order sanitisers + recommendations from World Health organisations to communicate to delegates.
- Evening programme:
- Plan time for a farewell video for the Bureau at the end of the Congress.
- Regarding the party part: 2 drinks per person + ticket system should be put in place. Theme: Roaring twenties was already announced.
- Invest in a data package for BM in need to be able to communicate on spot - Bureau communications line - 28 EUR/ 2 GB. We should have it upon arrival, we need to ask Sanda to give us local offers.
- Reports:
- Reports were submitted by members of the Bureau. Only one is still missing.



Handover to next Bureau (all)

- Document should contain the contacts with MOs and who is responsible but also where
- Bureau members to write about each person's area and state of relation with their MOs.

IMS Event Berlin (BG, EM)

News from IMS (EM, PCC)

- Nation builder:

- Half a year is needed before fully launched
- Next Bureau to discuss to move the website to Nationbuilder

AOB

- AA to go to Greece for Young Liberals Greece Congress so that they fulfill the statutory meeting criteria - video message from SH will be sent in addition.
- Letter from the National Youth Council Ukraine to help them with European Youth Forum membership: we never recommend it for National Youth Councils, we never worked with them in this case. We will communicate that we "support endeavours but not vocal on supporting national youth councils on this matter, not in our mandate we appreciate attempts and could eventually support on spot"
- Sergiu requested us a report for the FNF event in Chisinau from last May: we made clear that it is not our responsibility, there is no cooperation agreement for us to do this, he was the project leader.
- Online learning Platform (PCC) ELF project happening on this. We need to underline the importance of "skills" vs "theory and knowledge". BG will attend the workshop on this in Brussels.
- 1 May Julis Congress in Berlin DAS is going.
