## 1. Congress (30 min)

\*Roles and responsibilities

The Bureau discussed the last details and everyone reflected on their own tasks. Briefings were clear and last updates were shared by BG.

#### \*Logistics - metro tickets

MS and MP will buy the transport tickets for all participants to ensure smooth travel to the evening venues.

## \*Bureau reports and MO application

USR Tineret applied and the Bureau will give a positive recommendation to the Congress to accept them as full members. They will show a video to Congress. All Bureau members will be present at the stage for short comments and questions during the Bureau reports.

## \*MO suspension

## a. SMC Youth - Slovenia

An email was received from the new President willing for her organisation to be active again and pay their debts. If they pay then the suspension will not be proposed to the Autumn Congress, money needs to be in the account, proper proof of payment will be requested.

# The proof of payment was received during the meeting so the Bureau withdraws the suspension.

## b. Mladi LDP - Serbia

We move forward with the suspension and will see how to reduce their debt. We had no reply from them despite several attempts.

## c. Mladi Liberali - Bosnia/Herzegovina

Suspension is proposed since the last MO fee wasn't paid. They are waiting for new leadership to be active again and asked to be suspended in the meantime.

# 2) Finances (15 min)

## \*Closing of the year

- Two new laptops for SG and Assistant were bought and are in use now;
- End of the year will be a significant surplus again because the website and the Congress were cheaper than expected;
- We planned the internal and external audits for February 2022 already.
- New Alumni Network Board was elected and composed as follows: Daniel Kaddik, Jan van Run-Kvist, Svenja Hahn and Danica Vihinen. They are meeting next week to divide responsibilities, a signal group was created and access to the Alumni members' last was given. We clearly need more members and fundraising events will be organised.

## 3) Location of the next LYMEC Spring Congress 2022 - for decision (30 min)

Regarding the location, we need to check where it will be possible for people to connect. For the Spring Congress, we need to take four indicators into account before deciding:

- Price
- Location that is easy to reach connectedness
- How willing locals are to cooperate
- Access for non-EU

The Bureau decides that Skopje will not have the Spring but the Autumn one. The Bureau also decides that the Congress will take place at the end of May- between 20-22 May.

We will OPEN a CALL FOR CONGRESS hosting with pre-selected conditions as leading criteria. Accessibility for non-EU members to send delegations to ensure equal chance in the Electoral Congress. Current restrictions specifically for non-EU citizens. Budgetary constraints. Hybrid capabilities. Strong internet - strong local organiser team.

<u>Timeline as follows</u>: Wednesday opening of the call - deadline on 15 November. Final decision on the location on 6 December at the next Bureau Meeting.

## 4) Calendar 2022 - for decision (30 min)

The Bureau discussed and decided about the dates of the calendar for next year. It will be soon available on our website (by the end of the year) for everyone. We are expecting clarity about a few additional events and their dates. We will then release the final version.

## 5) Winter Academy - maybe - checking access to EP (6 to 10 December)

The rules to access the EP building for visitors will be revised on 3 November. They might decide to open it or not - depending on the pandemic. Not sure if the situation changes - maybe with the COVID certificate. We have to wait till 3 November and see if we go ahead with the Winter Academy and the Anniversary event.

The Bureau agrees that if no Winter academy takes place this year then we also postpone the anniversary event.

## 6) Suspension Civil Forum from Belarus - for decision

The Bureau was in touch with the main stakeholders and decided to lift the suspension - welcome them back in the LYMEC family. An e-mail is ready to be sent out.

The Bureau therefore welcomes the Civil Forum Youth of Belarus back. DAS will send out the email communication to them to let them know about the news.
