• Motions and resolutions

Motion with all the changes from policy working group reform was submitted.

Amendment starting the Congress will request to take out policy group work from resolutions point (statutory matters first then motion then wg policy process then resolutions separately).

Working groups: AA with Ciara and Ben (bureau changes + more controversial on defence + gender policy) and DR with Sissel in the other. Bàlint will send the proposal of repartition between the two groups to AA tomorrow.

Debated resolution on defence by JOVD "Defending Europe" not necessarily in line with our positions till now. Bureau to defend in London the position LYMEC managed to push for at the ALDE Congress.

Urgency resolution from JNC on the ruling of Spanish courts on Catalan separatists: Pau explains that it wasn't submitted yet in order to have more signatories.

#### Extraordinary request:

Marko Zivkovic from Nova Stranka, Serbia requested to cover part of VISA fee. Bureau decides that freedom fund and reduced participation fee can be granted but not the VISA fee. If they aren't joining at the end, we won't ask for late cancellation fee in this case. Lena to communicate this extraordinary decision by email. She will also emphasize that our MOs should consult LYMEC at an earlier stage in this kind of situation.
