

Minutes LYMEC Electoral Spring Congress 20-22 May 2022 Prague, Czechia and Online (Hybrid)





Day 1: Friday 20th May 2022

Congress starts at 16 h 00 CEST (Prague time).

Participants are attending in-person but also online (hybrid Congress).

The opening speeches were live-streamed.

1. Opening speech by LYMEC President

Antoaneta Asenova-Bihlmayer (LYMEC President) opens the Congress with her speech from the Congress room.

Antoaneta Asenova-Bihlmayer (LYMEC President): I am particularly happy to see you all here in person in Prague. Let's give a round of applause for our hosting organisation to make this happen with us. This is the last Congress of the standing Bureau. I am happy to see where this organisation is going. The past two years were not what I had pictured when I decided to run. We have had to think digitally by default, any social structure has had to really adapt to our new way of working, and we have had to start doing things online. This period was marked by a changed way of life. It was marked by a COVID pandemic and marred by a period of other crises. We are shattered by a blissful belief that the "never before" is here to stay. This mandate, as cliché as it might sound, was marked by the words "crisis makes way for opportunity". We have come out of this time as a much better organisation. We have a stronger office and a pretty clear stance within the liberal family about what the future of Europe should look like. I would like to outline one more evolutionary thing that the pandemic brought about. That is a change of mindset. I experienced a personal and great loss during this time and it made me realise that all that really matters is togetherness. It matters to listen a lot more than to argue and to understand where other people are coming from rather than to judge. Open your eyes and ears rather than close them to others who are different to you. I ran under the slogan that "together we can do more". I began to realise it is a lot more than that. Politics is about togetherness where we can listen to people, show them support and do good for other people. This is the true meaning of politics, to help others and leave a mark, even if it is only a small one. To leave a mark on your country or town, or to Europe as a whole. Thank you for giving me this opportunity to lead the organisation and do exactly that. It is my final plea and heritage to you to urge for more togetherness, understand each other more, and be together more. Together we can do more and achieve more. Because that is what liberals do. Thank you for these two years. Best of luck in your future endeavours.

Marketa Plesnikova (Chair) asks if there are any comments about the minutes from the Paris Congress from Autumn 2021, which the Congress have received prior together with the agenda. No one expressed any disapproval.

The Congress adopted the minutes from the 2021 Paris Autumn Congress as proposed.

7. Urgency of resolutions (in case of urgency resolutions handed in)

Marketa Plesnikova (Chair) explains that we have received one urgency resolution entitled Human rights in international sports events. We invite the mover to take the floor and justify the urgency of the resolution.

Sara von Bonsdorff (Chair) reminds Congress that point of orders and voting happens through Openslides only.

Sara von Bonsdorff (Chair): Elsie Gisslegard (Ombudsperson) is our ombudsperson. If there is anything you want to tell us during the Congress or if something unpleasant happens, you can turn to Elsie Gisslegard (Ombudsperson).

Sara von Bonsdorff (Chair) gives the floor to Rasmus Festerling Sorensen (Radikal Ungdom) to present the urgency of the resolution.

Rasmus Festerling Sorensen (Radikal Ungdom): Ourselves and JuLis have submitted a very similar resolution on the same topic. This is why we wanted to merge them. We want it to appear in our policy book. This was the only way to do it, by having the two resolutions merged since all other deadlines passed. This is the best fit for the LYMEC policy book.

Marina Sedlo (LYMEC Policy Officer): We want to vote in favour because both of the resolutions will be withdrawn if the urgency resolution is accepted and it's an important matter.

Marketa Plesnikova (Chair) reminds the Congress to always state their own name and the name of their MO when taking the floor.

Umberto Masi (LLJ): Personally, I don't see how the merger is so urgent. It is a technical merger. I would

like to see it happen, but I don't think it can happen.

Rasmus Festerling (Radikal Ungdom): Thank you Umberto Masi (LLJ), but I disagree with your point. I

think it is important and in LYMEC, we want to be strong community leaders when it comes to being

politically committed. We need to move now, be resolute, and have good policies to do so.

Marketa Plesnikova (Chair) opens the vote on the urgency of the resolution.

Bàlint Gyévai (LYMEC Secretary General) adds that if you are an associate member organisation, you

have the call to vote on Openslides, but you can't as you have zero votes (only full members can vote).

If you have voting rights as a Full Member Organisation, please do vote.

Marketa Plesnikova (Chair) closes the vote.

The result of the urgency resolution is as follows:

Yes-97 (59.146%)

No-62 (37.805%)

Abstain-5 (3.049%)

The resolution was not approved as urgent because it would need a two-third majority in order to be

carried which it did not receive.

8. Snap vote on the order of resolutions (with presentation of resolutions)

Marketa Plesnikova (Chair): I am sure you have seen the resolutions beforehand. You have 30 minutes

to vote on the order of resolutions. We will have quite a short time for discussing the resolutions

9. Bureau reports and debate about the reports

Marketa Plesnikova (Chair) invites Antoaneta Asenova-Bihlmayer (LYMEC President) to take the floor to present the Bureau reports.

Antoaneta Asenova-Bihlmayer (LYMEC President) asks Bureau members to join her on stage.

Antoaneta Asenova-Bihlmayer (LYMEC President): Apologies on behalf of Dan-Aria Sucuri (LYMEC Vice-President) who has been left stranded at the airport. Since our last Congress, we have organised a few events. The YCA is being worked on, we have had the first session of the Alliance of Her Youth Academy, which is an academy of leadership for young women, and a few sessions of an event called LYMEC Voices from Ukraine, which were targeted to give the floor to our Ukrainian MOs to shed light on their views about what is going on.

I would like to shed light on the Digital Assembly and give a broad overview of the last two years of my mandate. I would like to hope and believe that the LYMEC Bureau made the best effort to respond to quickly shifting demands of the crises and were as adaptive and responsive as possible. We adopted the LYMEC working programme in July 2020 to have a more professional LYMEC and I am happy to see that happening with a permanent Project Assistant and a Youth Liaison Trainee to ensure we have the sufficient manpower to provide you with the necessary trainings you need as well as policy briefings to ensure you are able to take a position on important European topics.

It is important to have cooperation between Bureau members and MOs with clear portfolios of what each of them does. The Digital Assembly was a fruitful practice. We believe it is important that you are kept informed between Congresses. We significantly improved the time you are allocated for questions and answers so much so that each member of the Bureau is responsive and answers over their own work being done. We further continued the streamlining of our working groups with a streamlined working structure as well as focusing on the IMS, with a Bureau member steering the IMS in doing their job. The system seems to be working. A lot of events were organised by the working groups and resolutions have been put forward. The IMS Steering Committee and new IMS have got involved with Marina Sedlo (LYMEC Policy Officer) acting as the point of contact. Beyond that, LYMEC has improved its visual identity as a recognisable brand, improving the digital instrumentalisation, improving our decisions, replacing the multitude of previous Congress platforms with Openslides and launching a new website. I am urging you to use the new platform as it is the single gateway to vote and do anything at Congress. I believe it was successful.

EUROPEAN LIBERAL YOUTH

Last but not least, as a horizontal goal, we strengthened LYMEC's relevance within the liberal family of decision-makers. We targeted our efforts on making the LYMEC views heard at the Conference on the Future of Europe (CoFoE), which came about as a result of your work known to many partners within the liberal family and beyond. We organised cross-party meetings, emphasising it is necessary to bring about real results from the CoFoE and not to have it as a talking exercise only. We created an advocacy database and, with the support of the ALDE Co-Presidents, we improved our standing within ALDE with the creation of the Alliance of Her Youth Edition and we secured our President's participation in the ALDE Leaders meeting. We executed our work with a lot of passion. I hope you can forgive some of our mistakes and I hope you see the good stuff which has been done as we have tried to bring the current ever-changing realities and important topics of the EU to you.

I would really like to thank all of the Bureau members. Marten Porte (LYMEC Treasurer), thank you for not losing our money. Marina Sedlo (LYMEC Policy Officer), thank you for carrying out the policy work which you have done with grace. Laia Comerma (LYMEC Events and Training Officer), with all the training and events, all the new events and creative ways you have thought of carrying these out. Thank you Ines Holzegger (Outreach and Cooperation Officer) for improving our standing in all partner organisations. To my vice-president Dan-Aria Sucuri (LYMEC Vice-President) who is maybe somewhere listening in an airport, thank you for taking over when it was really difficult for me and for stepping in and making tough decisions. Ida-Maria Skytte (Communications Officer), for responding to the non-stop flow of events in a nice visual way, creating visuals and not just posting stuff. I am proud of each of them. We are not perfect, we have made mistakes, but I could not hope to work with a better organisation. Thank you to Bàlint Gyévai (LYMEC Secretary General) for always being there for me and for being my support and work love. That is it from me.

Antoaneta Asenova-Bihlmayer (LYMEC President) opens the floor to questions.

Marketa Plesnikova (Chair) thanks Antoaneta Asenova-Bihlmayer (LYMEC President) for the report and asks the Congress to put their names on the speakers list if they wish to take the floor. She asks all speakers to be brief and remember that the questions need to end with a question mark.

Marketa Plesnikova (Chair) opens the floor for questions from the delegates.

Alice Schmidt (JuLis): Thank you to the Bureau. I think you did a lot of good work. For me as an International Officer (IO) of 16,000 members, it is sometimes hard to explain when we are only here

with 3 people. One Member Organisation (MO) is being represented by 3 people but there are other IOs here with 50 members and still 3 delegates. I wish that next time we have a Congress that even if we have a reduced number of delegates, we still should have a way of representing how big our delegations are like the European Parliament (EP) method does. I think the website is very intuitive and empowers you to get the information. It shows a lot of transparency and acts as a role model for other IOs in something they should thrive to achieve.

Marketa Plesnikova (Chair) invites the next speaker to take the floor.

Abram Guido Pieter von Backer (JOVD): Thank you. We are quite sad to see that something went wrong with the European Commission grant proposal. We are wondering what went wrong and what could have been done better to ensure that such a large sum of money is not lost again. Do you need any help from MOs to achieve this?

Marten Porte (LYMEC Treasurer): Should we maybe tackle this in the finances point and I will leave room for questions there?

Abram Guido Pieter von Backer (JOVD): accepts Marten Porte's (LYMEC Treasurer) suggestion to tackle the point at a later stage.

Antoaneta Asenova-Bihlmayer (LYMEC President): Thank you Alice for recognising the importance of our webpage. Really the platform and website are the two things along with increased transparency that I find really quintessential in what we did. In terms of people participating in Congress, I come from a large organisation. I also would like to see organisations with 10 votes coming with 10 people but it is very difficult logistically to host so many people. Maybe the next Bureau could look into this. The ALDE Party has Congresses of about 1000 people however, it can be hard to imagine youth parties organising something to this scale.

Abel Hartman (Jonge Democraten): My journey as an IO would not be complete without asking a question. Dear **Antoaneta Asenova-Bihlmayer (LYMEC President),** what do you see as the major big challenge for your successor and what advice would you give to them?

Antoaneta Asenova-Bihlmayer (LYMEC President): I will ask Umberto Masi (LLJ) to ask his questions first before replying.

Umberto Masi (LLJ): I tend to usually ask about what has been done in the last half of the year and about what you cherish and regret the most. What do you cherish most about the last two years and what did you miss the most? We are missing one organisation in the Congress, could you elaborate on the thought process behind this? Maybe they did not come because they did not want to? Questions about all cases will come up in the future and what will be done if other organisations have an internal struggle? We talk about Young Liberals Greece in this case.

Antoaneta Asenova-Bihlmayer (LYMEC President): The biggest challenge will be maintaining the liberal family. It is a work to keep fighting within our broader political family. You shouldn't be ashamed to be called a liberal. A centrist is not the same thing. It is a struggle we are facing daily. My advice to this is to never back down and to insist that liberalism is in our blood and we are not giving it up. Umberto Masi (LLJ), to answer your question, it is a difficult situation which will come about as Laia Comerma (LYMEC Events and Training Officer) will further explain. The Greek organisation was not invited to take part in our Congress in-person for the reason that they have an internal struggle and have two people/two fractions who claim to be representatives of the organisation. LYMEC is not an arbiter and we do not take sides. Unless the two sides are able to talk to each other and agree who should represent the organisation. Until they communicate this to us, we simply cannot toss a coin and we do not have that much authority to pick a side. What I will cherish the most is working with these amazing people and meeting you guys at Congresses. The policy discussion is fun to hear. The criticism is nice to receive as it makes our work better. Sometimes I do regret my temperamental defensiveness when it comes to the Bureau work. Thank you. I will give the floor to Benjamin Fievet (IFLRY Representative) to give his report.

Marketa Plesnikova (Chair) announces that the vote on order of resolutions has been closed.

Antoaneta Asenova-Bihlmayer (LYMEC President): Thank you to everyone for all your work. To the IOs and MOs who made the non-stop, never ending online events worth it. It was a privilege for me to be elected. Thank you and I hope to see you in the future after this Congress.

Benjamin Fievet (IFLRY Representative): This is my last report as IFLRY representative. I am reaching the end of my term. Just to reflect a little bit on the two years in my position. There was a time when LYMEC and IFLRY were not great friends. I think I have tried to improve that relationship. We have cooperated on a lot of things. Simon Lindkaer (YFJ Board Member) was elected to the European Youth

Forum (YFJ), and **Nicolas Paganokis (former IFLRY Board member)** was elected to the Council of Europe. We have regular contact between the two organisations on a lot of different levels. We have regular contacts at different levels between our Presidents and Secretary Generals. We wrote a memorandum of understanding and co-signed it last year. **Amanda Kanange (IFLRY President)** spoke here earlier. A lot of great things have happened. We tried to do some communications together with our Communications Officers. We could do some more campaigns and events together in the future. We need to understand each other's points of view a bit better in certain situations. I suggest organising joint sessions between the two Bureaus to have some fun together. On a personal level, I think I was very welcome in the IFLRY Bureau. I think I provided valuable input to you and I was clear when something was not working for LYMEC. On the LYMEC side, it was a bit tricky sometimes to approach the position as my mandate was appointed at Congress but I do not have a voice in the Bureau. I hope the next Bureau and IFLRY can make the communications a bit more fluid. Despite COVID and not getting to travel that much, I think I did as much as I could. I would have liked to have done more but thank you for trusting me over the last two years. Thank you.

Marketa Plesnikova (Chair) moves on as there are no questions following Benjamin Fievet's (IFLRY Representative) report.

10. Secretary General report and debate about the report

There are three of us in the office and we work together all the time in what is needed to achieve our objectives. Since the last Congress, the first main point is the restructuring of the office. We adopted a new approach, we now have two full staff members with Chiara Liguori (LYMEC Project Assistant) joining as the new LYMEC Project Assistant. This changed a lot. I would like to thank Chiara Liguori (LYMEC Project Assistant) for taking on the new responsibilities and now she is the new person responsible for taking over the organisation of events. I would like to thank the team. We now have a great team spirit. I would like to thank the Bureau. It has been great to have calls depending on the file or people coming to visit us to work on certain projects. I would like to highlight the cooperation between the Bureau and the Secretariat in these past 2 years. I am looking forward to your questions. Thank you to the team, secretariat and the Bureau for the past couple of weeks. We are here at your disposal and do not hesitate to talk more to your MOs about LYMEC. We hope to involve more people at national level and can count on the IOs and MOs to make that happen.

Marketa Plesnikova (Chair) opened the floor for questions. She gives the floor to Umberto Masi (LLJ).

Umberto Masi (LLJ): I just wanted to ask **Bàlint Gyévai (LYMEC Secretary General)** how he keeps being so awesome.

Bàlint Gyévai (LYMEC Secretary General): Thank you for the question. We all do our best I believe. It requires a lot of energy. Working at LYMEC is more than just the work. It is a true commitment in everything you do. It might just be for the members or the broader cause of liberalism. The commitment keeps us doing what we do. I would like to thank Marten Porte (LYMEC Treasurer) for being so caring on the HR side. A good working team is obviously a very healthy team. The pandemic was difficult for everyone but finding the right allies in the Bureau was important. We have regular evaluation meetings with staff members to ensure we move forward on this together. Thank you to Chiara Liguori (LYMEC Project Assistant), Amy McAuley (LYMEC Youth Liaison Trainee) and Sara von Bonsdorff (Chair) previously. When I hear that Chiara Liguori (LYMEC Project Assistant) is really enjoying the work, that also motivates me as well.

Marketa Plesnikova (Chair) thanks Bàlint Gyévai (LYMEC Secretary General) and moves on to the Year of Youth discussion. The Bureau decided it would be focusing on Ukraine this time due to the war. She mentions it is a really difficult situation and gives the floor to all three Ukrainian organisations who have 5 minutes to present the situation.

11. Year of the Youth 2022 - updates and discussion with the membership on Ukraine

EUROPEAN LIBERAL YOUTH

Marketa Plesnikova (Chair) gives the floor to Antoaneta Asenova-Bihlmayer (LYMEC President) to present what LYMEC is doing with the Year of the Youth 2022.

Antoaneta Asenova-Bihlmayer (LYMEC President): It is important to talk about the brainstorming behind the Year of the Youth as a continuation from the online calls with our Ukrainian friends who give us updates on how they are doing. This brings me back to our plea about more togetherness.

Antoaneta Asenova-Bihlmayer (LYMEC President) invites Anna Komziuk (LDLU) to take the floor.

Anna Komziuk (LDLU): These war days are very hard for all Ukrainians. Today is not the time for ideological discussions in Ukraine. We are all working for our economy and army as much as we can. From the LDLU, we helped our territorial defence, unions, those working in Donbas and Luhansk regions, we were finding fundings for weapons which we could buy and pass to the front line. We have also done huge work outside of Ukraine. I encourage you all to spread the information and not let Europe and the whole world forget about the war generally and all the war crimes. Repost anything on your personal and organisational accounts. That is what I would like you to start and continue to do. We have our strong team in Poland and we have some members who fled Ukraine who are helping volunteers and people to find shelters. In Belgium, I am searching for host families to give shelter to those who have fled Ukraine and am providing some legal service. I ask you to stand with us and support Ukraine. Thank you!

Antoaneta Asenova-Bihlmayer (LYMEC President) gives the floor to Olena Dudko (European Youth of Ukraine).

Olena Dudko (European Youth of Ukraine): I am representing the European Youth of Ukraine. I would like to thank everyone for standing with us and supporting us. While we are in Congress, war is ongoing in Ukraine and the Donbas region is still being bombed. I want to address everyone by saying right now that there is a lot of different analysis in the media about Ukraine. I want you to remember that there is a long way to go before Ukraine wins. There is no other option apart from Ukraine winning. There is no greater fear right now than fear for people's families. We have a member on the frontline where fighting is tense. We have two members who are students who are also fighting. We are trying our best to support them via finances or in any way we can. We spread information by talking to people in Europe and by explaining why it is important to stand with Ukraine. There are a lot of humanitarian initiatives

and other things in need of your assistance. The opposite of the word 'love' is not hatred, it is indifference. If there is no indifference and if we are all together and all united we can make Ukraine win. There is a war going on in Europe which has been going on for 86 days. We are living in hell, in atrocity and are experiencing war crimes by Russian soldiers. The people who have fled Ukraine are girls and women, as the men have been forced to stay in the country due to martial law. We are working with various medical and humanitarian initiatives such as those in Germany. I am based in Frankfurt and organise demonstrations there every two weeks. We have tried to revive our project work and hopefully in the autumn we will have the third edition of the Young European Women's Forum organised by the European Youth of Ukraine. We are trying to promote European and liberal values because that is what we stand for. Ukraine is an integral part of Europe and we consider ourselves Europeans. I would like to end with a quote: "Whoever learned freedom and what freedom is should not forget about it". Thank you.

Antoaneta Asenova-Bihlmayer (LYMEC President) gives the floor to Oleksandr Sanchenko (Ze!Molodizhka).

Oleksandr Sanchenko (Ze!Molodizhka): I am the President of Ze!Molodizhka and I am an MP focused on youth issues in Ukraine. Thank you Antoaneta Asenova-Bihlmayer (LYMEC President) for leading the idea for the calls every two to three weeks to share with young liberals what is going on on the ground, the Ukrainian perspective and what young liberals can do to help. The war did not start this year. It started in 2014 with the Crimea issue when the Eastern part of Ukraine was invaded. For the guys in the Kremlin it is more about doing things their own way. We chose not to go with them. We decided to choose Europe. This year we knew that this war had been planned for more than a year. They do this because we choose the European way. It is important to feel support from Europe. A European perspective is truly important. We want to join Europe. It is our choice. We can be part of the European family. War is still going on in Eastern Ukraine. People are still losing their homes every day. For the last few days, the currency rates have gone up and we have less money in the budget. That is why we need Europe to help us with a more balanced budget. We need help from Europe to have more balanced support. The end of the war will be when the Russian army will be crushed. Each single thing your country does will really matter. The longer the war is going on, the more people will be killed. Your voices as liberals are highly important. Glory to liberals and glory to Ukraine!

Marketa Plesnikova (Chair) opens the floor for speakers.

Alice Schmidt (JuLis): First of all, I want to thank you for coming to us here while you are having a war in your country. As a German, I am here to say sorry for the last 30 years of unjust German policy. Things like continuing to build Nord Stream 2 after many Eastern countries told us to stop. I want to say sorry for our Chancellor who is still lobbying for Putin. I want to say sorry that Germany did not realise that the danger was true. Until the 24th February, we didn't believe that they would invade Ukraine.

Umberto Masi (LLJ): Once again the least we can do is hug our friends who came here and look at the general feeling of how everything is going. For the first weeks of the war, everyone was very engaged in speaking and talking about Ukraine and engaging on social media. The longer it goes on, the less we see about it. I would like to call on everyone here. I am certain you are doing your utmost to get the news out there and share it among your peers, even those who are not interested in politics. We have to do our part. Ukraine is fighting for us. The only way we can help is continuously speaking about this and giving support to Ukraine. This is the only way to win the war. Slava Ukraini!

Marketa Plesnikova (Chair) thanks all organisations and promises we would do more for our Ukrainian friends.

12. Finances

That is why we are able to be with you today. Due to these circumstances, I believe we should not be limited, because our financial difficulties are outside our competences. I am looking forward to meeting you all.

Tim Robinson (IMS): I would like to ask for clarification. Should the fee be reduced to 5 or 15 euros?

Marten Porte (LYMEC Treasurer) clarifies they want it to be reduced to 5 euros.

Marketa Plesnikova (Chair) opens the vote for reduced membership for Nowoczesna Youth.

b) Financial report 2021 (for decision)

Marten Porte (LYMEC Treasurer) presents the interim financial report of 2021.

Marten Porte (LYMEC Treasurer): It was a good year for LYMEC. We only had one Congress and the website was much cheaper than what we planned. There are still 3 membership fees from 2021 that have not been paid. The debts are stable. There were not too many opportunities for fundraising in 2021, as the ALDE Congress did not take place, but we'll be able to do more this year. We can move to a vote on the annual financial report. If you have any questions on it, please take the floor.

Sara von Bonsdorff (Chair): Before we open a point on the agenda, you can already put yourself on the speakers' list. It might speed up the whole process. She gives the floor to **Phil Hackemann (JuLis).**

Phil Hackemann (JuLis): I have a question about the spendings. LYMEC is spending a lot on hotels. Is there a chance to reduce the spendings on hotels? I saw that in one of your Bureau minutes that you are planning to spend 5000 euros for a Bureau hotel for the ALDE Congress, which is quite expensive. Could we maybe go to a cheaper hostel?

Marten Porte (LYMEC Treasurer): I am not sure what you saw. The hotel cost depends on Renew Europe who organises our Congresses and big spendings directly go from Renew to the hotel. A few months ago, we didn't know there would be a financial setback which implies we have to re-evaluate our finances. There is a lot in between. Yes, Congresses could be cheaper. For Dublin, that is a big amount and Dublin is crazy expensive. We were lucky that we booked way in advance and got it for a decent price. It is true that we might cut back on some of the comforts of LYMEC events. This is something the next Treasurer might take into account.

Marketa Plesnikova (Chair) reminds the delegates that the vote is open and they can vote on OpenSlides.

Marketa Plesnikova (Chair) indicates that the report is approved.

c) Interim financial report January-April 2022 (for information)

Marten Porte (LYMEC Treasurer): This is about the last few months - the first part of 2022. Some questions about it were already raised. As you might have heard, the Erasmus+ operating grant which provided LYMEC with 50.000 euros per year was not allocated to LYMEC this year. They increased the amount of the grant significantly, but the total budget remained the same in the enveloppe. Less organisations are able to get more money. We made the proposal and got more or less a score of 72 points out of 100, which is usually enough to receive the grant. This time we didn't manage to get the grant and are 4 points down. This is a big setback for LYMEC. We can apply again next year. LYMEC can handle this situation now, but if we keep losing money and not receiving this grant, then we might need to cut some of our structural costs. Ines Holzegger (LYMEC Outreach & Cooperation Officer) and I have been working hard in the European Youth Forum (YFJ), as many organisations have also been hit by this. We have been working with them as well as with the EU Commission. It is outrageous to kick out most of the EU youth organisations from receiving the grant this year, taking in some others which do not necessarily focus on youth, especially given that it is the European Year of the Youth. We will see what we can do to influence the European Commission. I hope me or the next Treasurer can bring some news to you regarding this topic. It is important to make sure we get back into the lead group, preferably getting more money in the envelope to make sure more youth organisations can apply. We are also working more on the definition of a youth organisation. This is in a nutshell the Erasmus+ situation. This has impacted the budget for this year. Only in April or May you know if you get the money for the whole year. This is why at the beginning of the year we planned the budget taking into account the money of this grant. On a brighter topic, we now have the Project Assistant as a full-time employee.

Marten Porte (LYMEC Treasurer) addresses Abram Guido Pieter von Backer's (JOVD) question.

Marten Porte (LYMEC Treasurer): You asked us what you can do to help. Maybe your organisations have experience in applying for Erasmus grants or other European grants. Please get in touch. Maybe you could help us with proofreading and deliver better applications in the future.

Marketa Plesnikova (Chair) moves on to the internal audit report and gives the floor to Tuuli Helind (Internal Auditor).

d) Internal audit report (for information)

Marten Porte (LYMEC Treasurer) gives the floor to Tuuli Helind (Internal Auditor).

Tuuli Helind (Internal Auditor): I am currently the Internal Auditor of LYMEC. Unfortunately, Jeffrey Drui (Internal Auditor) could not be here. We conducted an internal audit this February in Brussels. We made three observations on the following topics: personnel, approvals and internal auditors. The points are explicitly explained in the report. More proof and record keeping is needed and the role of internal auditors needs to be made more certain as there are conflicting statements in our statutes. Without further ado, I would like to sincerely thank you all for the last three years. Thank you to Marten Porte (LYMEC Treasurer) and Bàlint Gyévai (LYMEC Secretary General). It has been really fun at times for people like me who like going into numbers. Thank you to Sanda Krekikj (Lidem) who did internal audits with me. I hope I can continue to work with this organisation in the future.

Marketa Plesnikova (Chair) thanks Tuuli Helind (Internal Auditor) for the report. Nobody wishes to take the floor. There is no vote on this point.

e) Revised Budget 2022 (for decision)

Marten Porte (LYMEC Treasurer): Since we didn't get the Erasmus grant, a hole had to be filled within our budget. We did not look for a complete balance in the budget. We have been saving and growing our reserves over the last few years. It is when you have fall backs that you should use reserves to soften the blow. One of the things we have decided on is to do the Congresses with fewer of our own resources. We will spend less on Bureau expenses such as meetings. There will be no LYMEC Project Fund for the next Bureau. There are extra taxes for the new Project Assistant that we hired to also take into account. The ALDE Party grant was increased by 15,000 euros to 100,000 euros so thanks to ALDE we get more money there.

Marketa Plesnikova (Chair) asks people to put themselves on the speakers' list if they were against the Revised Budget for 2022. Nobody is against it so the Revised Budget is approved. She gives the floor to Marten Porte (LYMEC Treasurer).

The Revised Budget 2022 was accepted by the Congress.

f) External Audit report (for information)

Marten Porte (LYMEC Treasurer): There was a report and it was on the website. That is all I have to add.

There is a sense of community together under the idea of the Ukrainian President who feels he could soon be the leader of the nation. We launched our organisation on the 13 March of the previous year but we have done a lot of work lately. The previous year we have built our structure to have a national and regional team in the districts. During this period, we are the biggest party in Ukraine and have the opportunity to communicate with members at different levels. We have over 5000 participants and representatives from all over the districts and over 103 leaders in the community. We are focusing on working on youth policy issues, creating educational, cultural and ecological projects. We had more than 1000 youth projects in 2021. The thing that differs from us and other organisations is that we focus on project creation. The President acts as a role model for us as he created some smaller projects which became bigger and then he became President which we believe in as well. We show our members how to create change on a local level. It is a personal thing on my level. We have adopted district culture in the law. The big action is the ecological part that we are doing through both small and large projects like planting trees, collecting trash and blood donations. Youth Democratic Movement Vesna Russia for Full Membership.

Timotey Gorodilov (Vesna Youth Movement): We have belonged here since 2016. We are already an Associate Member and are a member of IFLRY. We were created in St. Petersburg where freedoms in Russia were being squeezed and there was growing authoritarianism. We participated in elections and have 84 members. 40 percent are in Russia and the rest have moved abroad since the war. We have

several cities where we are active with our five branches.

Mariia Lakhina (Vesna Youth Movement): The most important thing for us is an anti-war liberal Ukraine. We are pro-European and pro LGBTQI+ rights. Talking about the war, we totally understand that applying for Full Membership being from Russia could seem a bit weird at the time. I cannot express how shaken we have been since February 24, 2022. When we woke up in a country starting a war, the only thing we could do was to try to stop it. Under an authoritarian regime, what we can do has been limited. We have organised street actions such as performances and rallies. We have created a lot of petitions, open addresses, and we have tried to educate the people. We produced a lot of anti-war propaganda. Here

are some images to show that not everybody in Russia supports the terrible things that have been done.

Vasily Neustroev (Vesna Youth Movement): There are two criminal cases which our members are involved in. One is for terrorism and another is for creating an NGO that violates civil rights. Russian criminal law is used for distraction but now it has been used for political repressions. Here you can see on the pictures someone under-home detention who is under investigation now.

Mariia Lakhina (Vesna Youth Movement): We hope to continue to develop our organisation and to

promote human rights in Russia. Thank you!

Virginie Cavalli (Young Liberal Greens Switzerland): Dear delegates, dear members of the Bureau, dear presidency, dear liberal friends. Today I am honoured to introduce you to the Young Liberal Greens Switzerland. I will say a few words about our organisation, who we are and if you want to speak about the Swiss political system after the presentation, I can do it later as it is a complex system. In a world where populism is rampant, it is important that liberal forces unite more than ever. Firstly, how we are organised and who we are. We are the youth of the Green Liberal Party which was founded in 2007. We, as the youth of this party, were founded in 2016. That is very young for the Swiss political world which makes us the new kids on the block. Originally, we were a small group of passionate volunteers and then we grew up very fast and are now numbering more than 3000 members. We have a Bureau which is the managing organ of our organisation. We have a co-presidency, where I am co-president with one of my colleagues from the Swiss-German part. We have a Secretary-General, the only person who is paid in our organisation, and a steering committee with representatives of the cantons. The general assembly is our supreme organ which makes all important political decisions. We have working

groups who work for them. We speak four languages officially in Switzerland and we have united national parties and that's why we always like to represent the French and German speaking parts of Switzerland in the presidency, which are the biggest minorities. Politically speaking, our focus is on being green and liberal. It is a unique case in Europe. It is possible to have an ecological accession which does not fight against the economy. They have to work together, and the economy needs to be involved liberally in the green transition. The party has the possibility to build coalitions and it is important to have parties like us in Swiss politics. We were fighting a lot for agreements with the EU and kept pressure on the government to have good relations with Europe. We are a centre party and hope to keep good relations between right and left. We recruit talents and vote four times a year in Switzerland. We also host referendums.

Rasmus Festerling Sorensen (Radikal Ungdom): Thank you for the presentation. I was reading your mission statement and I would ask you to define your individual responsibility in healthcare.

Virginie Cavalli (Young Liberal Greens Switzerland): The cost of healthcare in Switzerland is exceedingly high and we have a role to find out how to reduce it. It costs a lot for the working class and it means we have to pay a lot. For healthcare, I have to pay almost 20 percent of my income every month. It could not increase indefinitely as my income would not support that.

d. Disaffiliations

Keith Henry (Chair) explains that there is one proposed disaffiliation and gives the floor to Laia Comerma (LYMEC Events and Training Officer) to explain the situation of Young Liberals Greece.

Laia Comerma (LYMEC Events and Training Officer): It is a very sensitive topic. I would ask for respect and understanding in this conversation. I know it came quite suddenly to people but I am here to explain. Traditionally, we rely on members on the ground to explain what happens but I am living in Greece, I was at the event and I saw in first-person what happened. We have one full member organisation who joined us last year. I personally promoted it and I stood in front of you last year giving a positive recommendation when they received over 90 percent of the vote. What happened last November is that due to an internal crisis, the organisation got split in two. Half of the organisation roughly went with the previous International Officer (IO) who became President, Theodoros Sofianos (Young Liberals Greece), while the other half stayed with the former President, Eleni Siapikoudi (Young Liberals Greece) who became IO. The half that went with Theodoros Sofianos (Young Liberals Greece), had their own General Assembly and Congress on 8th January where they elected their new leadership and amended the statutes. Eleni Siapikoudi (Young Liberals Greece) developed a caretaker board until they had a Congress on 18 March. During this period she also legalised the organisation under her leadership so there was a change in legal status of the organisation. Basically now we have two organisations, both had their own Congress, both sent an email to LYMEC claiming to be the representatives of Young Liberals Greece and we cannot claim anymore that the organisation that joined LYMEC last year is the same one that is in existence now as we have two. Our proposal is to put forward their disaffiliation so that each of them have the opportunity to reconcile or separate to see what their future is nationally. They could potentially present their applications as associate members of LYMEC in the future and start afresh after these troubled times.

Keith Henry (Chair): Both representatives have five minutes to present the situation. They are joining us online.

Eleni Siapikoudi (Young Liberals Greece): Dear friends, good morning. Unfortunately our organisation is not present in Prague with all of you due to unfortunate disagreements which I will share with you now. Over the last months of 2021, the Board had decided to conduct re-elections. The process was delayed due to disputes about the rules of elections. Some members were ultimately trying to convince the Board to change the statutes and voting rights of members days before the election. The statutes which we were elected to LYMEC must unquestionably stay the same. Many people may say we were not a legal entity but the whole credibility and future of the organisation is to be transparent. Despite the fact we had agreed on dates of the re-elections, these disagreements did not allow for us to proceed properly. This group of people had online elections, chose an electoral committee without any authority, did not inform the membership of their election and went against the statutes. At that period, we had 80 members and only 9 called for a re-election. Finally, on the 19 March the electoral committee called for re-elections. Despite the previous miscommunication and disagreements, we decided to invite everyone to discuss our disputes and agree on a way forward. The other group did not reply to our messages and did not seek further cooperation. We cannot agree with the disaffiliation of the organisation as a whole due to some members leaving and using our name and work. We urge for your support as we are young members without a mother political party in the turbulent Greek political space. We do not wish to promote hard feelings. We are all young liberals and we want the best for our organisation but have different opinions on how it can be achieved. It is time to stick by the legal statutes and I am willing to answer all your questions. Thank you.

Keith Henry (Chair) gives the floor to Theodoros Sofianos (Young Liberals Greece).

Theodoros Sofianos (Young Liberals Greece): I am really happy to be with you even in unfortunate circumstances. Having to disaffiliate a project me and Eleni Siapikoudi (Young Liberals Greece) have been working together on for two and a half years, feels like getting stabbed in the heart with a knife. The situation got so bad so fast. The situation with the previous board was very problematic. Only 2-3 people were very active. We were recipients of great external forces from our partners, not youth nor liberal, putting an extra burden on our backs not allowing us to find a solution. The 80 members Eleni Siapikoudi (Young Liberals Greece) argued about are 14 full members as of late December who had a right to vote according to our statutes that were submitted to LYMEC. Of the 17 full members, two had quit and one was over age. Out of this, 10 people supported my petition for an urgent general assembly and elections. There is a great file, both in size and content, that the LYMEC office has, talking about why what we did was completely legitimate. What Eleni Siapikoudi (Young Liberals Greece) failed to remind you is that on 31 December, New Year's Eve, I received an email saying that I would be expelled from the organisation from a general assembly that was called at 11 in the morning and I should come

with a defence about alleged accusations that were never there. This fictional move, sci-fi and self-proclaimed general assembly finished in 3 hours. It decided I should be expelled from the organisation. From then on, I had no will to fight for that so I tried to do what the statutes said. I got these 11 members together with new members and we decided to have a legitimate general assembly 10 days after that one. Since then we have grown a lot, gained new members and partnered up with the largest student liberal party. We created a big protest in favour of Ukraine which gathered around 6000 people and was covered by the media. We became partners with the biggest think tank in Greece (KeFim) that supports liberalism and who is a member of the ELF. We have received confidence and support from Liberal Alliance and Volt Greece and all the big liberal and centrist parties in Greece. The Friedrich Naumann Foundation (FNF) agreed to support us in the next year and I have written confirmation of that in case you are uncertain about this. It may seem like two parties are arguing against each other. I can assure you that this issue ends today. On a personal note I can say that the issue has been partially resolved with Eleni Siapikoudi (Young Liberals Greece) as we are talking to one another but not about the issue. In any case, my part of the organisation will move forward with a rebranding and a new legal status, hopefully with your help. Thank you for your time and I am open for questions.

Keith Henry (Chair) opens the floor for questions.

Laia Comerma (LYMEC Events and Training Officer): We are not deciding who is legitimate, we are deciding if we want to keep them as one full member with the both suspended until they figure out or disaffiliate them so that they can apply in the future as one or as two individual Member Organisations.

Benjamin Fievet (IFLRY): This has been an issue which has been brought up in IFLRY and discussed. IFLRY believes in the same approach as LYMEC and will discuss at our next general assembly to expel them and give them the opportunity to reapply as IFLRY should not have a say in the internal politics of member organisations.

Kasper Langelund (Radikal Ungdom): A question to the Bureau or speakers. How many people are there on each side?

Laia Comerma (LYMEC Events and Training Officer): From those 14 full members, 13 went to Theodoros Sofianos (Young Liberals Greece), while the majority of associate members went with Eleni Siapikoudi (Young Liberals Greece).

Eleni Siapikoudi (Young Liberals Greece): If I am not wrong, the number presented by **Theodoros Sofianos (Young Liberals Greece)** is not correct. I can't agree on that. The people represented here on the new board are around 30.

I have already discussed with our partners about having more events which are not only based on discussion, but also on concrete outcomes that make us feel like we have contributed to something. We are very ambitious here. I have been here for almost 4 years and I have never had any regrets. This is what I want to dedicate myself to. If you agree with me, please support my candidacy.

Keith Henry (Chair): There are no questions, thank you **Dan-Aria Sucuri (LUF)** for your presentation. The votes will start now and remain open until the end of lunchtime.

Vice-President

Ines Holzegger (JUNOS): Thank you very much. I could tell you a long story of how I was a liberal in a conservative setting, how I became active or passionate about EU politics. What I want you to know is that my main motivation is change. If I get elected, I want to actively support the President, the Bureau and Secretariat to make change and reflect it in your MOs. I have had the opportunity to work with you in the past and I still want to cooperate with you and go even beyond what is required sometimes. I talked to some of you about my ideas. I want to preserve our diversity which makes us really strong. I promise that if you give me your support I will do everything to make LYMEC more future proof, accessible and politically impactful. I would love to get your support in the next two years as Vice-President.

Marten Porte (Jonge Democraten): Dear liberal friends, In the last two years I have been lucky enough to play an active part in the professionalisation of LYMEC as your Treasurer. In Dublin in 2 weeks, LYMEC will celebrate its 45th birthday, and we can be proud of the progress we made. However, there

is still a lot to do to make sure LYMEC's voice can not be ignored at the next European elections. But more importantly, to make sure that LYMEC will be around for another 45 years. For that, we will have to be willing to make structural reforms. I believe my experience as a Treasurer has thoroughly prepared me for this. Despite the difficult situation you heard about yesterday, -assuming you were all listening-LYMEC is moving forward. For the first time we hired a second full-time employee in the office. This is not only a huge step for LYMEC as a professional organisation, it also comes with a great responsibility for us as a Bureau. Because not many people realise that the LYMEC Bureau is actually an employer, and that this comes with certain duties. We have a duty to make sure our employees can develop themselves in their jobs, we have a duty to do everything we can to take care of their mental and physical wellbeing. And we have a duty to make sure that they are treated equally. I can safely say that in none of these areas LYMEC is currently in danger, but we can do more to ensure that we stay on the clear side. That is why I want to provide, depending on our financial situation, a budget for professional training for the office. Not just to increase the professionalism of LYMEC, but also for our employees self-development goals. On top of that, I want to organise frequent meetings between me and our employees to hear directly from them how they are feeling in their job and what we can do as a Bureau to make their lives easier. They workdays, nights and weekends out of a deep love for this organisation, but that means that we as Bureau should never take their hard work for granted. Even though I believe the internal side should be the main priority of any Vice-President, I also have some ideas on how LYMEC can become more relevant on the political stage. I want to use the new way the office is structured to improve our political communication, and I hope to use the increased training possibilities to equip the office for some of these responsibilities in return for other tasks. On top of that, we need to be bolder. We are a youth organisation, and we should behave like one. Not defending the status quo but challenging it. We shouldn't fear what others will say of us, they should fear us for what we'll say about them. We will have to be more vocal if LYMEC's voice is to be heard and staying silent is not an option. Because if there is one thing that Ukraine has shown us, it's that a united, liberal Europe is worth fighting for.

Questions to the candidates:

Rasmus Festerling Sorensen (Radikal Ungdom): My question is for both the candidates. What is the greatest future challenge according to you and do you personally believe you can further integrate the MOs into lobbying processes?

Marten Porte (Jonge Democraten) Thank you. A few weeks ago the biggest challenge was the secretariat reform, especially for the Vice-President. I have told you that new challenges have come to us like the operating grant from the EU Commission. As regards the second question, there are many

ways we can perceive integration. IOs can get a proper introduction to regional representatives and

make sure they attend our events.

Ines Holzegger (JUNOS): I agree with Marten Porte (Jonge Democraten) on lobbying for a solution for

the operating grant. This is a big issue for a lot of organisations. This is the internal most pressing

issue. In two years there will be EU elections and from an external perspective, LYMEC should

encourage young people to actually consider running for elections and make those people seen on the

ALDE and Renew stages. As for integrating more MOs, I think taking advantage of digital tools can

make events more accessible and encourage people to be active. This is a way of involving people

more.

Keith Henry (Chair): tells the delegates to get off the WiFi for better connection and invites them to take

the floor for questions.

Stefania Reynisdóttir (Uppreisn): We can all agree we have two really good candidates. I want

to ask you both which qualities are you going to bring and how are they going to help you in

your mission?

Ines Holzegger (JUNOS): I don't want to talk about how I am better than Marten Porte (Jonge

Democraten) but of course we are very different people. My strongest quality is experience with other

MOs, and I would like to use it to coordinate with other youth organisations to have an impact when

lobbying. I would like to be this link. As Vice-President, you are also responsible to work with the Bureau

and make sure the work is smooth and everyone is feeling safe. I have the compassion to work with

everyone and make the next Bureau even nicer than this one.

Marten Porte (Jonge Democraten): I agree with you, we both have our assets. I am very aware of all the

internal processes of LYMEC. It is always good to have an extra pair of eyes on the finances and I was

involved in the staff as well in terms of the HR side of things. I think the internal process should be the

Laia Comerma (JNC): I want to make LYMEC an active policymaker.

Keith Henry (Chair): next question please.

Rasmus Festerling Sorensen (Radikal Ungdom): If you could only choose one, should LYMEC focus on communication and lobbying or cooperation with MOs and training?

get elected, getting elected and not having the time to do the job. I asked myself if I had ideas and

something to propose before running. I apologise that I haven't spoken to all of you but we have a lot

of members. To answer your question, I am not saying that I don't believe in non-formal education, I am

saying I want to go a step further in having our own members being able to train themselves and be

trainers themselves. When it comes to politics and you want to engage with the youth, young people

Johannes Brill (LHG): I have a question for Laia Comerma (JNC) about the Alliance of Her. As

you are a candidate, are you going to continue working on that project?

Laia Comerma (JNC): Hopefully we will be able to train women from all your MOs in the future, because

we want to make this Academy a recurrent event.

Keith Henry (Chair): next question please.

Gijs Toussaint (Jonge Democraten NL): I have guided the members of my organisation with the application process for LYMEC events. It is frustrating to hear that some people have the feeling LYMEC is not accessible enough and they are discouraged because they feel they are not enough. What can the next Bureau members do to avoid that?

Felix Schulz (IMS Delegate): I think it is important that we highlight the cool things about LYMEC. Each and every one of us needs to be vocal and active about it in our personal lives. We need to include more people in our working groups. My idea about the 'sustainability working group' is that I want to include experts in the IMS. We need to make the working groups more accessible from the outside.

Christine Khomyk (LYMEC IMS): Personal connection is the key. This means more transparency to reach out to MOs individually. Not all MOs can be equally represented at LYMEC events, so members do not have the same level of knowledge about LYMEC.

Ellinor Juth (Svensk Ungdom): It is sad to hear people do not feel good enough for LYMEC events. We need to be transparent, state what is expected from you as a participant and communicate to MOs the knowledge they need. We should engage everyone equally.

Cristian Preoteasa-Maier (USR Tineret): Everytime there is an event we should communicate events and create a direct channel. Bureau members should become ambassadors for the events. We should create regional events for those who are discouraged by taking long flights.

Laia Comerma (JNC): From the policy side they can diversify the way that they participate. They could come to Brussels to meet with someone or people could provide some background research for policies or briefings. It is easier to jump inside once you make the first contact with LYMEC. It is a family you just can't get away from.

Alexandre Servais (Jeunes MR): We need to work on concrete things. We have experience as IOs but for new IOs the transition might be a bit rough. They are the new ambassadors of LYMEC in their MOs. We should also invest in the regional responsibility of each Bureau member. We should be able to tell them what is needed from them and make events more accessible.

Tanzer Yuseinov (Youth MRF): I agree with all the candidates. To make the events and opportunities for attending events accessible, we need to reach out to a broader audience so more people can apply. We need to have an easier application process. People need to answer too many questions and

loana Abaseaca (USR Tineret): Today we welcomed two completely new organisations in LYMEC and being in a bigger organisation can be somewhat underwhelming. What would you do to make these new organisations integrate as fast as they can?

Ellinor Juth (Svensk Ungdom): I would do monthly follow-ups to be implemented in the Bureau in the field of communications. As for the communications team, I think it would spread the tasks better and become an asset for LYMEC.

Cristian Preoteasa-Maier (USR Tineret): We are talking a lot about human rights and how Europe should become the standard for human conditions. We should support the ban on Russian gas. We need to stop being hypocrites when it comes to setting standards. We want to be something new and a lot of people want to live here. I know how it is to be an MO and I love when people come and talk to me. We need to make new MOs welcome. I am more than happy to talk to you.

Laia Comerma (JNC): EU-China policies should be the priority for us on the global stage. The EU needs to use all the tools in its power so that we can stand as a global power in front of all the dictatorships around the world. We should also be the strongest partner for Ukraine. I am here to answer any questions.

Alexandre Servais (Jeunes MR): Integrating new MOs is also about participating in events. Seeing people only once every 6 months makes it harder to integrate. We have to push people to take part in our events. I also want to push people to be proud liberals and united by liberal values. We need to be proud of the EU.

Tanzer Yuseinov (Youth MRF): The EU should push for democracy and find a way to make decisions faster. When it comes to new MOs, we can organise calls with them to show them how LYMEC works and how they can contribute.

Felix Schulz (IMS Delegate): Regarding the internal motion submitted, we actually implemented this social media squad and the idea is that you share the burden with several people when something major happens like the war in Ukraine, so you can discuss it and post something. Regarding the incentives, I am in favour and would like to promote it. You need to train people. If we take four or five people and train them about political communications, it would be something they can put on their CV. Regarding the EU in the global sphere, we have to consider the reality of the unanimous vote in the Council we are bound by, but it doesn't mean we can't be vocal about what is going on in Ukraine. We should call out Viktor Orban if he is against certain topics which go against human rights. Regarding new organisations, I am totally up for the task as it is a question of personal involvement. Every Bureau member needs to be active and go the extra mile.

Christine Khomyk (LYMEC IMS): Three things are important: ensuring peace in Europe, solving all the crises and problems that stem from the war in Europe and ensuring stability. Second question, LYMEC has to empower people and connect to them. It can be done either by assigning Bureau members to organisations and helping them lead. Another option is the buddy system.

18. Election of the Internal Auditors and substitutes (presentations, questions and voting)

Keith Henry (Chair) explains the elections: 4 positions will be up for voting but only the best two get to be the actual internal auditors, the other two remain substitutes. He gives the floor for 2 minutes to each candidate. There are four candidates.

Presentations from the candidates:

Katrina Keita Ruzaike (Attistibai Youth): Dear liberal family, I am standing here at the Congress for the first time, and I am sharing with you this message to introduce myself and explain why I want to be an Internal Auditor. My name is Katrina, and I am 22. I am a parliamentary assistant in the



Latvian parliament to a parliamentary secretary and I am on the board for Attistibai Youth. I have a bachelor's degree in political science. I am pursuing my Masters' Degree in theology to recognise social and political leaders. I have experience in the administration of project finances and auditing. My job responsibilities included summaries for the European Commission and the OECD. My job experience has given me expertise in national policy development and has provided me with great responsibility. Since last summer, I have been a chairwoman in committees in Latvia, for young women with disabilities, environment and town planning. From this year, I have been a member of the Alliance of Her where I have tried to stress human rights in Latvia. I believe in transparency and openness and the significance of liberal teaching. Regarding my past experiences, I consider myself a proper candidate for the Internal Auditor position. Thank you and good luck.

Daniel Ruiz (Jonk Demokraten): Dear friends, this is my first LYMEC Congress and I want to start by thanking you for the warm welcome. I am from 'Jonk Demokraten' from Luxembourg, and I am running for Internal Auditor. Trust and accountability are key to ensure LYMEC's success. We need auditors to scan the organisation to assess problems. Based on my discussions with Jeffrey Drui (former Internal Auditor) and Tuuli Helind (LYMEC Treasurer), we have identified important changes to the role. The internal auditors are to scrutinise the accounts and general management of the organisation. I appreciate Tuuli Helind's (LYMEC Treasurer) and Jeffrey Drui's (former Internal Auditor) work. Finally, I would like to mention that I have professional experience in internal audits in KPMG Luxembourg. I kindly ask for your support. Thank you.

Sara von Bonsdorff (Svensk Ungdom): I am Sara and I come from Svensk Ungdom and you might have seen me in the secretariat and as a chair but I am standing here today to ask for your support. I have been an active member in LYMEC since 2017 and have participated in working groups and in the secretariat as an administrative assistant. During my time there, I got a good overview about how LYMEC functions and its internal structure. I have worked in a political role in Svensk Ungdom and have gone through the books with my own internal auditor. Before LYMEC, I worked in a Finnish investment bank where I was tasked with gathering the legal documents of new potential clients. Based on the internal audit report, I believe that we should work together to ensure the best for our employees. I can tell from experience that it is a very high-paced environment and I want to work for a healthy workplace where everyone can thrive. The Internal Auditor should look at the books but also HR tasks and internal management of the organisation. Both as a former IO and employee, I believe I am equipped for the task, and I thank you for your support.

Katrina Keita Ruzaike (Attistibai Youth): Humans because humans have an animal nature.

Keith Henry (Chair): Throughout the day we have nearly every species covered.

Tim Robinson (IMS Delegate): Firstly, I just want to say that in the institute of internal auditors' code of ethics that it is not acceptable for the internal auditor to have a spirit animal. Tuuli Helind's (LYMEC Treasurer) report highlighted that the role of Internal Auditor has been misunderstood. The role of the Internal Auditor is to assess the risks the organisation is exposed to and how to mitigate them which requires independence and objectivity. How can you reconcile your deep commitment to LYMEC and being critical in case of facing pushback from the Bureau or Secretariat?

Sara von Bonsdorff (Svensk Ungdom): I was part of the Secretariat and was very pleased that the ideas and suggestions I had were very well received. This doesn't mean that they were perfect, but it is an example of how I helped LYMEC through those small things. I like communication a lot. LYMEC has on my own initiative bought a professional camera to get better pictures and professionalise our communications. About being biased or non-biased, I am a person of strong opinions. Despite my connection with LYMEC I do not fear to get on with the big questions that need to be asked.

I used to be a member of the local parliament of the FDP for 6 years and was the regional President of the Young Liberals and I am the IO of the Young Liberals Switzerland. There is hardly any political discussion that has not become international. I want to spread my liberal values and that is also one of the reasons for my candidacy. Some of you know I consider myself a classical liberal. It has been in my DNA since my grandfather and father have been active in liberal politics. At the end of the day, LYMEC and IFLRY have one common goal: to spread liberal values across the world and bring liberal ideas to young people's minds. I want to organise events and have a stronger exchange of best practices and I want to mediate and establish better cooperation between the 2 organisations. As a representative of a non-EU state, I could be in a good position to mediate between the 2 organisations as I am out of certain prejudices that may exist. With my political experience, language and social skills I can bring important abilities to that position as IFLRY representative. Thank you.

Marten Porte (Jonge Democraten): As you can imagine, I have not prepared a speech. I did not expect to stand here. Congratulations to Ines Holzegger (LYMEC Vice-President) who had an amazing campaign and deserved this. When I thought about the possibility of losing, I said it would be such a shame to lose either of us for LYMEC. I decided if I didn't make it, I would run for IFLRY representative because this organisation has such a special place in my heart. It has been such a passion for me to work with LYMEC. I have been IO for Jonge Democraten. I have been a representative at the IFLRY Congress and know the organisation very well. I believe I have a diplomatic talent in bringing the organisations together and from the Bureau, I understand how the position works and the relationship between LYMEC and IFLRY. I know it is a hard decision and a weird turn of events for you and I hope I can put effort and energy into LYMEC again for the next two years. Thank you!

Keith Henry (Chair) opens the floor for questions.

Questions to the candidates:

Benjamin Fievet (IMS): I have been in this position which requires a lot of diplomacy. How would you approach this position if there is a conflict between IFLRY and LYMEC particularly if there was a conflict of interest knowing that you are representing LYMEC but sit on the IFLRY Bureau? LYMEC are the people you answer to. How would you reconcile this? And also, what is your spirit animal?

Marten Porte (Jonge Democraten): I am elected by the LYMEC Congress so that is where loyalty should be. A big part of preventing conflicts is communication. I would immediately flag to the Bureau if there would be a conflict in IFLRY. I have some experience in solving conflicts between organisations.

Rasmus Festerling Sorensen (Radikal Ungdom): You said that your commitment is to liberal values but we know that LYMEC is a huge organisation spanning many liberal values. How would you personally feel defending a position you or your organisation would personally disagree with?

Philipp Eng (JFS): I always do have my own opinion but if I am representing an organisation, that is the only opinion that matters.

Marten Porte (Jonge Democraten): I have to say things that I do not always agree with but that is part of the job and I do not have an issue with that at all.

Keith Henry (Chair) proposes to take two questions at a time.

Johannes Brill (LHG): Marten Porte (Jonge Democraten), when you ran for Vice-President, you said you would not run for any other position. I am confused by your candidacy so please take a stand on that.

Sandra Daniel (LUF): Especially given the context of your position, what do you think the role of the EU and Europe is in terms of global responsibility?

Marten Porte (Jonge Democraten): What I said when I was asked about what else I could do in LYMEC, I said it would not be up to me. I would try to be active in any way possible. This is the most direct way I can stay active in LYMEC and use the knowledge I built up over the last two years. The other question was the role of IFLRY in Europe. Europe is the richest continent on earth which brings responsibility also in terms of financial support. The whole world should get the same opportunities as we do.

Philipp Eng (JFS): It is a very interesting question. The EU for me is one of the most astonishing programmes of peacekeeping. I know it is weird these days, but the idea was not to have war in Europe. Europe tries to have liberal values of freedom which I want to represent.

Abel Hartman (Jonge Democraten): Could you talk about your IFLRY experience which will allow you to build your relationship between the two organisations?

Philipp Eng (JFS): to address Alice Schmidt's (JuLis) question, on the one hand, I want to bring in more communication and best practices. We need to work together where it is helpful, but we need to clarify and define that LYMEC can decide and do what the Congress decides. On the other hand, cooperation is something important. The more you cooperate the better you communicate and work together. I want to bring the two organisations together where it is needed and helpful.

Marten Porte (Jonge Democraten): To clarify, I have stressed indeed my will and passion to keep supporting LYMEC as I believe it is necessary to explain why after running for Vice-President, I am now running for IFLRY representative which does not mean I do not have ideas to bring to IFLRY. But I don't want to exaggerate the IFLRY representative role. The IFLRY representative is an important bridge between the two organisations. It should not look like I should be the one person Bureau organising events. It is a bridge and communications role. To answer Abel Hartman (Jonge Democraten), I was the IFLRY representative of the Jonge Democraten in Sofia and Barcelona, working on resolutions and in working groups with organisations to build bridges. I hope that I can count on your support.

Kateryna Onischuk (European Youth of Ukraine): I vocalise some remarks that can embarrass you hence I urge you to cover your ears when I raise my hand and to resume listening when I lower my hand if need be. According to the convention, genocide means any of the five acts prescribed herein: killing members of the group or causing serious physical or mental harm to individuals with intent to destroy in whole or in part a national or ethnic group as such. 300 metre mass graves full around Mariupol. A friend of my teacher was tortured and killed for being a Ukrainian. Triplets, 9-year-old girls raped by Russians and have severe genital injuries. All this happened in front of their mother. A one-year-old boy was raped and died. They rape women in front of their children and Russian soldiers' comment, on social media too, for Ukrainian women to never want a Ukrainian man, for them to carry babies of Russian blood. Mass stealing of grain, the siege of Mariupol and the stealing of food and medication for weeks. Occupants threaten farmers to plant grains and transfer everything to Russia otherwise they will be shot dead. Russians transport Ukrainians, children included to occupied territories cynically calling it evacuation. Russia kidnaps our children and develops national legislation for their adoption. They are allowing in their state to change the birth dates and names of these children to be changed so that after the war ends, their biological parents will never be able to find them, which destroys their national identity by forcible re-education. The father of the genocide convention emphasised that genocide is not only about the physical destruction of a person but also of their political and cultural institutions, dignity and finally life. Admit the truth. Recognise the genocide. We the Ukrainians, as you can see by my emotions, have no need to exaggerate things. In Ukraine today it is Europe Day so in some ways congratulations and the parliaments of Lithuania, Canada, Latvia, Estonia, Poland and the

Sara von Bonsdorff (Chair): The chairs agree. If anyone is against it please make a point of order on

the speakers' list. Nobody adds their name to the speakers' list so the speaking time is now limited to

one minute.

Louis Souliac Ruffier D'Epenoux (FEL): I have a question for the movers. Is it only a resolution that aims

to put forward classical liberal principles in which case my predecessors answered specifically or is it

a sly tactic to strike down half of the policy book which goes against their vision of liberalism?

Alice Schmidt (JuLis): There are many market incomes and if you look into the resolution you will find

no word of criticism against social liberalism. It is just about the market and market principles. The

market brings good things out and brings about the most successful ways to deal with climate change.

If you think classical liberalism, markets and climate change are not in line with us then what are we?

Benjamin Bergan (Svensk Ungdom) raises a POINT OF ORDER.

Benjamin Bergan (Svensk Ungdom): Why are we discussing the motion and not the amendments which

might change some people's mind? I am proposing we move to discuss the amendments rather than

the resolution.

Sara von Bonsdorff (Chair): Putting yourself on the speakers' list means you are against this. As there

are no names appearing, it means we are moving on to the amendments.

Sean Bennet (Young Liberals): We believe it is unwise to force this upon the government which hampers its ability to govern and react to sudden changes effectively. It is not for the EU to judge on what sovereign states need to collect money for. For those who might disagree, we ask that you support us. We are not in a position to decide the role of sovereign states and say what they should put their money on.

It brings up an ideology which not everyone in this room can agree to so please vote against.

Maarten Tollenaar (Jonge Democraten): A common complaint about liberals is that we accuse people of not having followed economics 101. The resolution seems to have forgotten about competition law and basic principles about game theory. We know more about how our economies work. Please vote against the resolution.

Victor Rundqvist (Centerstudenter): I do believe that the country that focuses on freedom over equality will have plenty of both. People should be acting free from oppression of the state. This is why I support this. We are not arbiters of state sovereignty. It is good to emphasise freedom. I am in favour of the resolution.

Phil Hackemann (JuLis): This whole debate got very emotional with very little arguments about the content against the resolution. Of course, as liberals and as LYMEC, we can also adopt resolutions which are based on our core values. Market liberalism is part of our core values. Vote in favour of this resolution.
