# (#6) RESOLUTION for a new and fresh approach to solve the actual political and financial crisis Resolution #6 presented by Ermano Matignetti (GIV, Italy). Following amendments were received:

Amendment #1 presented by Lukas Schweiger (LLJ, Lithuania) To: replace lines 1 to 95: into the entire text with the following:

"Reaffirming LYMEC's liberal stance on Europe's sovereign debt crisis

The European Liberal Youth (LYMEC),

deeply concerned about the fact that since the onset of the crisis, none of the measures employed, including numerous bailouts, the EFSF etc., have stabilised the Eurozone;

strongly convinced that further steps towards debt mutualisation and a weakening of the currency, such as Eurobonds, Stability Bonds or the ECB's Sovereign Bond Buying Scheme would deepen the crisis;

believing that liberal ideas based on a sound currency, balanced budgets, and a free common market would be best suited to solve the ongoing crisis;

also believing that it should be the borrowers that took the risk should also be the ones bearing the cost, not the average European citizen;

reiterates this consistent approach towards the EMU and fiscal responsibility expressed by the Congress held in Konstanz in December 1992 through the resolution *On the Future of European Unity,* in March 1997 by the Congress held in Helsingborg through the resolution *On the Economic and Monetary Union,* in April 2003 by the Congress in Vilnius through the resolution *Upholding the Stability Pact,* in Sinaia in April 2010 through the resolution *Capitalism is not to blame for the crisis,* in Ljubljana in November 2010 through the resolution *Liberal ideas on the future of the single market,* in Barcelona in November 2011

through the resolution *On Europe's sovereign debt crisis*, and in Copenhagen in 2012 through the resolution *On the future of the Euro*.

These ideas include the opposition to further bailouts and all debt mutualisation schemes, a stronger and strictly enforced Stability and Growth Pact, an independent ECB, a sound and non-expansionary monetary policy, writing off debt of heavily indebted countries, and not dismissing their potential exit from the Eurozone".
