# "Article 2 - Application process

All membership applications must be received at the LYMEC secretariat at least six weeks prior to the Autumn Congress where will be dealt with the application. All written material must also be provided by the said deadline and must be sent out to all members at least four weeks prior to the Autumn Congress."

RULES OF ASSOCIATION - Chapter 1 - Article 4: Deleted "The year an organisation has been accepted as applicant member, it does not have to pay a membership fee."

"Representatives of observer member organisations of LYMEC have the right to:

- 1) attend LYMEC events;
- 2) speak;
- 3) propose motions or resolutions;
- 4) take part in a LYMEC working group."

The Delegates are also elected for all extraordinary congresses taking place in between ordinary congresses.

Delegates cannot be member of the LYMEC bureau or be LYMEC internal auditor at the same time. Delegates need to be individual member of LYMEC."

"Delegates have to be themselves individual members, and are elected for a year. Their duties towards LYMEC and the individual members shall be properly specified by internal rules of the Individual Members' Section; LYMEC's Bureau shall guarantee the existence of such rules and oversee their correct application. Delegation of votes from one or more delegate to other delegates of the individual members is allowed, and must be justified in written form to the Bureau and Office. Delegation of votes to member organisations is strictly forbidden. During the first two thirds of the mandate, if for compelling reason a delegate cannot fulfil his mandate, a by-election shall be organised.

An individual members' delegate cannot simultaneously be either a member of LYMEC's bureau or a LYMEC's internal auditor."

RULES OF ASSOCIATION - Chapter 3 - Article 13 - Paragraph 3: Change "representatives of the observer member organisations without voting rights" to "representatives of the observer organisations, in the status of the guest of LYMEC, without voting rights"

RULES OF ASSOCIATION - Chapter 3 - Article 16: Added

"Proposals of resolutions must be handed in with one general tag according to the list given on the website and three specific tags that are related to the specific policies approached in, or affected by, the resolution.

Resolutions approved at the Congress are added to LYMEC Policy Book and distributed electronically to members no later than two weeks after their adoption.

A resolution can ask for the archiving of maximum three resolutions older than three years if they share at least the same general tag and one specific tag, which are added to a LYMEC Policies' Archive Book. An explanatory note may be sent in addition, though not being part of the resolution, to justify the need for archiving of previous resolutions."
