Membership in NGO "LDLU" is voluntary and individual.

Members of the Organization shall be: citizens of Ukraine, foreign countries citizens and persons without citizenship who stay in Ukraine legally, have reached the age of 14, recognize the current legislation of Ukraine and the Charter of the Organisation and undertake obligations to comply with them.

Admission to the Organization shall be given on the basis of a written application of the candidate addressed to the President of the Organization. The Council of the Organization makes a decision on admission of person as a member of the Organization and makes an appropriate record in the Register of the members of the Organization no later than in two month after obtaining the written application in which person confirms an obligation to comply with this Charter and a written agreement to allow processing of their personal data according to the statutory objectives and current legislation. Participation in other public associations and political parties shall be coordinated with the Council.

The Council of the Organization may refuse to admit a person to the membership of the Organization, including the right not to provide explanations for such a refusal.

Persons born after 1991 are admitted to the Organization.

Declare any links (direct or indirect) with any other organisations and explain in full detail what form that link or dependence takes.

Since LDLU is independent NGO we have not links (direct or indirect) with national political organizations. We are just full members of IFLRY.

Provide information on its sources of finance, this must include details of any State funding, party funding, membership fees, annual turnover and the budget.

Our main sources of funding are membership fees. The annual membership fee is 350 UAH (approximately 11 EUR), the entrance fee is 50 UAH (approximately 2 EUR). The annual membership fee for students is 175 UAH (approximately 6 EUR).

Our budget 2018 includes 25000 UAH (approximately 750 EUR).

The applicant organisation must have been present at a minimum of five events, which shall include at least one statutory meeting, organised by LYMEC prior to the Autumn Congress where the application is considered.
