All members of the mother party Viðreisn from ages 14 to 35 are automatically members of Uppreisn. The number of members in Uppreisn (as of 05.02.2020) are 502.

Uppreisn is the youth wing of ALDE member Viðreisn (The Liberal Reform Party). Uppreisn has a representative in the mother party's board, parliamentary group meetings and Reykjavík city council group meetings. Uppreisn acts as a check and balance on the mother party's activities and decisions but operates independently and is unafraid of publicly challenging the party's policies. Uppreisn is a member of the Icelandic Youth Council (a full member of the European Youth Forum) and has a representative at every Council meeting.

Uppreisn funds its activities through several means. Our main source of revenue is an annual deal made with our mother party, wherein we receive funding in exchange for providing certain services to the party. Such projects include volunteering for big party events, organizing informative events for various students' associations at local universities to promote party policies, and more. To receive this funding, we present our proposed annual budget in detail to the party board who accept it provided it meets their conditions. This year we plan to raise at least 1/3 of our budget ourselves, in exchange the board provides the rest. Uppreisn thus fundraises some of its budget, through sale of books and promotional material. Uppreisn does not charge any membership fees. Our current budget (as of February 2020) is approx. 400.000 ISK (2890€ current XR) with the projected annual turnover of approx. 600.000 ISK (4335€ current XR).
