Radikal Ungdom (Social-Liberal Youth Party of Denmark), Copenhagen (Denmark)

- **Responsibility:** Sitting on the executive committee, which consists of seven people in charge of daily operations in an organisation with over 1,000 members active on the domestic and international fronts. These responsibilities include managing our yearly budget of over DKK 2 million (over €270,000), handling politically and personally sensitive crises, and strengthening intra-organisational relations among the various bodies in Radikal Ungdom. As the International Officer, with two committee members reporting to me, I am responsible for all the international work of Radikal Ungdom. This includes foreign aid projects run on behalf of the Danish Youth Council, which in turn is financed by the Danish Ministry of Foreign Affairs. It also involves pursuing our strategy and political goals in our three umbrella organisations —Nordic Centre Youth, European Liberal Youth and the International Federation of Liberal Youth. This means getting our candidates elected to leadership positions in these organisations and enshrining our policies in their manifestos, attempting to shape the international liberal youth in our own image. Lastly, I am responsible for Radikal Ungdom's study trips, election trips and seminar trips abroad.
- **Output:** I have honed my organisational skills and acquired experience in crisis situations involving sensitive information. Managing a relatively limited budget. Multitasking a lot while still ensuring quality output. Furthermore, I learned how to keep good teamwork going and keep a cool head even in extremely stressful situations.

I have been a leading policy-maker and have thus influenced Radikal Ungdom policies on international security, space, law, the EU, etc.
- **Output:** As the national board consists of 35 members, it has developed my presentation and debating skills exponentially. Policy drafting has also become one of my defining skills due to my experience on the national board.
